De Beers Consolidated Mines (Pty) Ltd lodged an application for a prospecting right for kimberlite hosted diamonds over several properties in the Lejwaleputswa Magisterial District in the Free State Province. The extent of the prospecting right application is 7811.2674ha.

A Basic Assessment Report submitted for Environmental Authoizations in terms of the National Environmental Management Act, 1998 and the National Environmental Management Waste Act, 2008 in respect of listed activities that have been triggered by applications in terms of the Mineral And Petroleum Resources Development Act, 2002 (MPRDA) (as amended) was uploaded to the case on 13/06/2016 along with the appendices.

The prospecting activities to be undertaken include non-invasive (desktop studies and ground geophysical surveys) and invasive (drilling) techniques. The drilling programme will include Core drilling and Large diameter drilling on two (2) targeted sites each with an aerial extent of 0.64 Ha.

The maximum depth of such holes is typically 400 meters where the cover is thin, and 600 meters where the cover is thick, and 8 boreholes are anticipated to be drilled per target. The activities carried out will require the clearing of vegetation as well as topsoil stripping and stockpiling, drill pad compaction, erection of office, toilets and fuel storage as well as water tanker and core storage.

McGregor Museum Department of Archaeology was appointed to provide heritage specialist input as part of the EA Amendment application report as required by section 24(4)b(iii) of NEMA and section 38(3) and 38(8) of the National Heritage Resources Act, Act 25 of 1999 (NHRA). The Heritage Impact Assessment Report along with the Environmental Authorisation (EA) and Prospecting Right (PR) documents were uploaded on the 16/11/2020.

No artefacts or heritage features of any kind were found in the study area nor in the wider landscape over up to some 50 m or more radius around it, however it is possible that material may occur below the surface. Access to the site would be along existing farm tracks to the immediate vicinity of the drill site and no impacts along the route area are anticipated. Archaeological significance for the drilling site is LOW.
