The Mhlabatshane and surroundings bulk water supply scheme, Mhlabatshane and surroundings, KZN

Nine heritage sites were noted during the survey of the three routes. The Preferred Option has one site, MHLO7, Option 3 has one site MHL01, while Option 2 has seven sites. Since the Preferred Option of 5,4km would have the lowest impact on heritage sites, it is the best option as outlined in the HIA.

In view of the findings outlined in the HIA Report by Gavin Anderson of Umlando that we received for the above proposed development, we have no objection to the proposed development within limits of the prescribed mitigation measures and recommendations.

You are also required to adhere to the below-mentioned standard conditions:

Conditions:

1. Amafa should be contacted if any heritage objects are identified during earthmoving activities and all development should cease until further notice.
2. No structures older than sixty years or parts thereof are allowed to be demolished altered or extended without a permit from Amafa.
3. No activities are allowed within 50m of a site, which contains rock art.
