A Heritage Impact Assessment Study For The Proposed Ndumo Rental Stock Housin, Ndumo North, Jozini Local municipality, Umkhanyakude District Municipality, KwaZulu-Natal, South Africa.

We acknowledge receipt of your invitation for comment with regards to the proposed development. The general area of proposed development is very sensitive in terms of heritage values as it is a landscape associated with human occupation spanning a long time. It is also a very highly sensitive area as reflected on the paleontological -sensitivity map. While the Heritage Impact Assessment by Nkosinathi Thomose of NGT Projects did not yield any heritage resources within the development footprint, it is noted that the Heritage Impact Assessment did not include the paleontological assessment. In terms of the paleo-sensitivity map the very high sensitivity nature of the area calls for field assessment and protocol for finds .Considering that the site photos presented do not show any evidence of fossil deposits on the surface ,development may proceed within limits of the following site specific and standard conditions.

Site specific Conditions:

Monitoring of the project is required. A Paleontologist has to be on site during earth -moving activities to monitor the site for evidence of sub-surface fossil or paleontological material. This should include access roads and construction campsite as the area is a very high paleo-sensitive zone.

You are also required to adhere to the below-mentioned standard conditions:

Conditions:

- 1. Amafa should be contacted if any heritage objects are identified during earthmoving activities and all development should cease until further notice.
- 2. No structures older than sixty years or parts thereof are allowed to be demolished altered or extended without a permit from Amafa.
- 3. No activities are allowed within 50m of a site, which contains rock art.
