A review of the documents reveals that the survey by Wouter Fourie of PGS Heritage Consultants established that this area is culturally sensitive that would require a site specific heritage management plan and an archaeological walk down as well as a Phase 1 palaeontological assessment of the final designed alignment and foot print areas of the proposed final alignment.

We concur with the recommendations put forward by Wouter Fourie of PGS Consulting and to this effect, the development may proceed as planned once a Cultural Heritage Management Plan (CHMP) of the development area and camp-sites as well as the Paleontological Report has been submitted and approved by Amafa before site clearance and construction phases commence.
