The permit application in respect of the above, received on the 20 July 2013, reviewed by Amafa on the 24 July 2013, refers. Please be advised as follows:

The previous structures (outbuildings for the block of flats "Park Lane") on this site were generally protected under Section 33(1) of the KZN Heritage Act (10/1997 & 4/2008) and 34(1) of the National Heritage Resources Act (25/1999) in order to allow the building/s on the site to be assessed for conservation worthiness when application was made to alter or add to or demolish the structures on the site. Amafa previously assessed these outbuildings to have no heritage significance.

It was clear from the application submitted that the current building and the other structures on the site have no conservation worthiness or significance as envisaged in the heritage legislation.

A permit cannot be issued in this instance since the building does not fall under the general protection of the Acts referred to above. Amafa, therefore, has no objection to the proposed alterations to the existing building.
