# **Final Comment**

# In terms of Section 38(8) of the National Heritage Resources Act (Act 25 of 1999) and the KwaZulu-Natal Heritage Act (Act 4 of 2008)

Proposed Nositha Road Upgrade, Nositha Village, Ward 27 ,Hibiscus Coast Local Municipality,Ugu District. The existing road to be upgraded is a Type 6 District Gravel Road, 4.4 km in length and 5m wide.The project will involve the resurfacing of the Nositha Main Road to black top, and the construction of stormwater drains.The construction will occur at six different positions of existing culverts.

The application for comment in terms of section 38(8) of the National heritage legislation and NEMA comprising of the Heritage Impact Assessment Study by Gavin Anderson and the Basic Information Document by Afzelia Consulting has been reviewed . The Heritage Desktop Study highlights that while historical maps indicate that several settlements and/or buildings occur within 50m of the proposed road ,most of these have been destroyed and/or built over. It also stresses that some will not be affected by the road upgrade and fall outside of the road reserve. These homestead sites could harbour graves and should be treated as sensitive areas. All graves outside formal cemeteries are generally protected by heritage legislation and should not be disturbed, damaged, altered or exhumed and relocated without a permit from Amafa and written permission of relatives or concerned families in this community.

Since it is indicated that the development entails road upgrade and refurbishing of existing storm water culverts it is not anticipated that the development will encroach beyond the existing footprint. In the event that the developer considers road widening beyond the existing footprint, a phase 1 HIA is triggered and the developer should engage the services of a Heritage practitioner to conduct a field based assessment involving mapping out sensitive zones including graves as some homesteads are abandoned and are not necessarily known and protected by community members. The map should be used by the construction team to avoid inadvertent damage to graves and sensitive areas .

Amafa has no objection to the development provided that the developer operates within the prescribed parameters.

You are also required to adhere to the below-mentioned standard conditions:

Conditions:

- 1. Amafa should be contacted if any heritage objects are identified during earthmoving activities and all development should cease until further notice.
- 2. No structures older than sixty years or parts thereof are allowed to be demolished altered or extended without a permit from Amafa.
- 3. No activities are allowed within 50m of a site, which contains rock art.
