PROPOSED CONSTRUCTION OF OFF TAKE 5B POTABLE WATER PIPELINE AS PART OF THE LOWER THUKELA BULK WATER SUPPLY AT HYDE PARK, ILEMBE DISTRICT MUNICIPALITY, KZN

Thank you for notifying us about this development proposal. A field survey of the area of proposed development conducted by Gavin Anderson confirmed presence of archaeological sites that were noted during the desktop survey. These sites referred to as HYP1, HYP2 and HYP 3 consist of small scatters of undecorated Late Iron Age or Historical Period pottery sherds across the top of the hills. These sites have been rated to be of low significance due to the severe transformation of the land due to cultivation. The developer will require a permit to partially damage all of the sites.

According to version 2 of the fossil sensitivity map (<http://www.sahra.org.za/map/palaeo>) the area is considered to be of low palaeo-sensitivity and therefore does not require further studies.

In view of the findings outlined in the HIA Report by Gavin Anderson of Umlando that we received for the above proposed development, we have no objection to the proposed development within limits of the prescribed mitigation measures and recommendations.

You are also required to adhere to the below-mentioned standard conditions:

Conditions:

1. Amafa should be contacted if any heritage objects are identified during earthmoving activities and all development should cease until further notice.
2. No structures older than sixty years or parts thereof are allowed to be demolished altered or extended without a permit from Amafa.
3. No activities are allowed within 50m of a site, which contains rock art.
4. Sources of all natural materials (including topsoil, sands, natural gravels, crushed stone, asphalt, etc.) must be obtained in a sustainable manner and in compliance with the heritage legislation.
