Umgeni Water is investigating the implementation of a pipeline from Wartburg reservoir to Bruyns Hill reservoir. The pipeline will replace the existing infrastructure that currently supplies water to the Swayimane area and will ultimately supply the Msilili and Tafamasi areas in the iLembe District Municipality as well.

Thank you for affording Amafa ,the Provincial Heritage Authority of KwaZulu Natal the opportunity to comment on this development proposal. It is noted that a heritage impact assessment of the proposed development done by eThembeni Cultural heritage identified no heritage resources within or immediately adjacent to the proposed development area.

Amafa , therefore has no objection to the development within limits of the prescribed recommendations and mitigation procedures.

You are also required to adhere to the below-mentioned standard conditions:

Conditions:

1. Amafa should be contacted if any heritage objects are identified during earthmoving activities and all development should cease until further notice.
2. No structures older than sixty years or parts thereof are allowed to be demolished altered or extended without a permit from Amafa.
3. No activities are allowed within 50m of a site, which contains rock art.
4. Sources of all natural materials (including topsoil, sands, natural gravels, crushed stone, asphalt, etc.) must be obtained in a sustainable manner and in compliance with the heritage legislation.
