Thank you submitting a permit report for the mitigation, assessment and detailed sampling of Stone Age Lithics **Site (K-01)** to be impacted by the Fritz 02 Burrow Pit located on Portion 2 of the Farm Fritz Near Kathu, Gamagara Local Municipality, Northern Province. Site K-01 was successfully mitigated with 280 Ston Age artefacts sampled from six **Block Samples (B1-6)** and three **Test Block (TB1-3) at the Fritz Burrow Pit site.**

The following recommendation are provided:

- No removal of sub-surface material (rock, soil) from the immediate perimeter of the Fritz 2 Borrow Pit in order to infill/close the old borrow pit. A buffer of 10m around the delineated extent of the Archaeological site K-01 must be kept in place.
- No scraping/ground clearance at the K-01 Site without an archaeologist being present to monitor the work. All material that will be used for the closure/rehabilitation of the Borrow Pit must be sourced from other locations, with the use of old stockpiled material recommended.
- Should material be sourced from areas that have not been impacted by borrowing/construction activities before then these areas will have to be assessed as well for the potential presence of cultural heritage sites and material as well.
