SAHRA issued a permit for exhumation and relocation of graves protected under section 36(3) of the NHRA. The permit eventually expired and an extension permit was issued which expires in July 2023. A complaint has since been received which alleges that exhumation was undertaken without consent by families. The grave in question is younger than 60 years and would have been permitted under the Human Tissue Act as the permit issued by SAHRA specified that graves that fall outside the NHRA must be permitted by the responsible authorities. As standard procedure, SAHRA hereby suspends Permit 3292 issued under Case13095. While SAHRA is only mandated to authorize exhumation and relocation of graves that are 60 years old and above, we recommend the following:

- 1. All exhumation activities must be suspended until the complaint is resolved.
- 2. The complainant, Mr Mthembu must be consulted to find an amicable solution regarding mitigation of his graves(s).
- 3. Proof of consultation and agreement must be forwarded to SAHRA.
- 4. It must be established whether such a grave was permitted under the NHRA legislation or the Health Act.

- 6. It is strongly emphasized that SAHRA will only lift the suspension if satisfied that all outstanding issues with the custodians of the grave(s) in question have been concluded. It remains the responsibility of the appointed Heritage specialist to ensure that the prescribed Public consultation is conducted and that all related complaints are effectively resolved.
