The construction of a new shopping centre in Newlands, eThekwini Municipality has been proposed. A total of approximately 5280m2 is envisaged for the construction of the shopping centre, however the property falls within D'MOSS zones and has a watercourse in the South Western quadrant. These two factors trigger the need for environmental authorisation.

We acknowledge receipt of your invitation for comment with regards to the proposed development. The area of proposed development is sensitive in terms of heritage values as it is in an area where some significant heritage sites were recorded. It also falls within the belt that triggers the need for a desktop study in terms of the palaeontological sensitivity map.

Considering the heritage value of the area of proposed development, **a Full Heritage Impact Assessment is required for the proposed project**. This should include a paleontological desktop study and any other components deemed necessary by the Heritage Practitioner. This will determine whether or not a full paleontological assessment is required. Amafa KZN Heritage therefore requires the appointment of an Amafa accredited Heritage Practitioner to assist in the provision of recommendations and mitigation procedures.
