A specialist eye hospital is proposed at 5 Alan Paton Avenue, Pietermaritzburg, for the purposes of specialist eye examinations and surgery. The hospital is to operate as a day hospital and the site is currently the Alan Wilson Shellhole and Bowling Club, Pietermaritzburg, KZN.

We acknowledge receipt of the Phase 1 Heritage Impact Assessment Report by Frans Prins of Active Heritage and the Phase 2 Architectural Specialist Report by Lindsay Napier as well as the Draft Basic Assessment Report. We note that the Amafa Built Environment Plans Review Committee has accepted and approved the application for demolition, subject to consultation with neighbours and that the required consultation with neighbours is currently underway. We also note that the Phase I HIA identified presence of military memorabilia, the tank and cannon which will require to be moved to an area 50m away .

Amafa therefore approves the development on condition that the developer meets the Built Environment Plans Review Committee Permit conditions and the conditions regarding the military memorabilia, tank and cannon that is to be moved to the position agreed to by the MOTH.

You are also required to adhere to the below-mentioned standard conditions:

### Conditions:

- 1. Amafa should be contacted if any heritage objects are identified during earthmoving activities and all development should cease until further notice.
- 2. No structures older than sixty years or parts thereof are allowed to be demolished altered or extended without a permit from Amafa.
- 3. No activities are allowed within 50m of a site, which contains rock art.
