Basic Assessment Process and Water Use License Application for the Proposed Expansion of the Existing Gowrie Farm Estate, Located on Erf 1065 of Nottingham Road, within the uMngeni Local and uMgungundlovu District Municipality, Nottingham Road, KwaZulu-Natal

Thank you for submitting this application for comment. While the heritage study by Frans Prins did not find any cultural heritage resources on the development footprint, the proposed development is located in a fossil sensitive zone. A paleontological assessment and protocol for finds is therefore required before development is given a go ahead.

Amafa KZN Heritage therefore requires the appointment of a Heritage Practitioner specialising in the paleontological component of heritage resources to conduct a fieldbased assessment with a view to assisting in the provision of recommendations and mitigation procedures.

The Study should cover:

- Identification of all heritage resources in the development area and its surroundings -50m
- Assessment of the impact of the development on such heritage
- Evaluation of the impact of the development on heritage resources relative to the sustainable social and economic benefits to be derived from the development
- Results of consultation with communities affected by the proposed development and other interested and affected parties regarding the impact of the development on heritage resources.
- Consideration of alternatives if heritage resources are affected by the development
- Mitigation plans for any adverse effects during and after completion of the project
- Table of all heritage resources identified .This should show Heritage resource type, description, location, significance and reasons for this rating.
