**The proposed forestry projects by Memela, M.W. (25ha) in respect of the same activity occurring in
several locations in Boucher 15069ET Portion 1 farm in Umzimkhulu and Ubuhlebezwe local
Municipalities within Sisonke District of Kwazulu Natal Province**

We acknowledge receipt of the Heritage Impact Assessment Report by Gavin Whitelaw et al. Although the Archaeological records indicate that a spearhead was uncovered in the vicinity of the Memela Farm in 1974, the current survey did not yield any cultural material within the development precinct. There is therefore no reason why development cannot proceed from a Cultural Heritage perspective.

In view of the findings outlined in the HIA Report by Gavin Whitelaw, Frans E Roodt and Frans Roodt of Shasa Heritage Consultants that we received for the above proposed development, we have no objection to the proposed forestry activity.

You are also required to adhere to the below-mentioned standard conditions:

Conditions:

1. Amafa should be contacted if any heritage objects are identified during earthmoving activities and all development should cease until further notice.
2. No structures older than sixty years or parts thereof are allowed to be demolished altered or extended without a permit from Amafa.
3. No activities are allowed within 50m of a site, which contains rock art.
