The Heritage Officers Committee considered your application on 01 March 2023. The committee note that the unauthorised deviation were done when the applicant had previously obtained a condonation letter for deviating without a permit. This therefore is a deliberate violation of the KwaZulu-Natal Amafa and Research Institute Act No. 05 of 2018 and the National Heritage Resources Act No. 25 of 1999.

Therefore, the committee resolved to request for an affidavit from the applicant, stating reasons for the violation of the above mentioned Acts. The applicant must indicate in the affidavit why they continue to violate these Acts.

Failure to comply with the requirements of the National Heritage Resources Act and the KwaZulu-Natal Amafa and Research Institute Act would mean that no authorization will be given.
