The proposed development entails approximately 112 residential units., and associated infrastructure. The total extent of the project area is approximately 1Ha.

The archaeological assessment yielded no surface evidence of heritage resources or features.

The palaeontological assessment notes that the potential impact of the development on fossil heritage is Low for the Klipriviersberg Group. The Environmental Control Officer should follow the guidelines as stipulated under the Chance Find Procedure of the report.

Final Comment

In terms of archaeological and palaeontological heritage, the SAHRA Archaeology, Palaeontology and Meteorites Unit has no objections to this proposed development, provided that the recommendations in the specialist reports and this comment are adhered to, and in addition, on the following conditions:

- If any evidence of archaeological sites or remains (e.g., remnants of stone-made structures, indigenous ceramics, bones, stone artefacts, ostrich eggshell fragments and charcoal/ash concentrations) or palaeontological remains are found during the proposed activities, SAHRA must be alerted immediately, and a professional archaeologist or palaeontologist, based on the nature of the finds, must be contacted as soon as
