The proposed development entails the construction of a total of 27 000 housing units within a total area of 391ha to accommodate the relocation of residents from the Khutsong Hostel, Khutsong Extensions 1 and 6 as well as the Khutsong informal Area. Development will include associated infrastructure such as roads and water supply.

The author notes that no sites of cultural heritage significance were identified within the project study area.
