PROPOSED SUPPERCHICKS POULTRY FARM ON PORTION 68 OF THE FARM KAMEELZYNKRAAL NO 547 WITHIN CITY OF TSHWANE METROPOLITAN MUNICIPALITY, GAUTENG PROVINCE, SOUTH AFRICA. SuperChicks proposes to construct a hatchery of 6 broilers estimated to produce a maximum of 76 800 eggs set per week.

The proposed development entails a poultry farm and associated infrastructure.

The archaeological assessment yielded one Middle Stone Age stone tool in the form of a flake that is a scatter without any context. It also yielded a stone-walled structure that is recent in age and not of Cultural Heritage Significance; the structure was built in the mid-1990s and is less than 60 years old. No other archaeological and heritage resources were found on site.

The SA Palaeontological Sensitivity Map indicates that parts of the study area have High fossil sensitivity. No palaeontological assessment is attached to this case.

Interim Comment

In terms of palaeontological heritage, the SA Palaeontological Sensitivity Map indicates that parts of the study area have High fossil sensitivity, therefore a palaeontological desktop study is required. Once this study has been submitted, SAHRA will be able to provide further comments.
