**The applicant has proposed to develop residential complex development with associated infrastructures on an area of approximately 2,78 hectares in Bronkhorstspuit, City of Tshwane Metropolitan Municipality, Gauteng Province.**

**Van Schalkwyk, J. November 2019. Phase 1 Cultural Heritage Impact Assessment: The Proposed Umnotho Mews Residential Complex And Filling Station Development, Bronkhorstspuit, City Of Tshwane Metropolitan Municipality, Gauteng Province**

The proposed development entails a residential complex to be known as Umnotho Mews on Erf 2495 & 2496 and a filling station on Erf 2494 (Portion 12 of the farm Klipeiland 524JR) in Bronkhorstspuit, City of Tshwane Metropolitan Municipality, Gauteng Province.

The archaeological assessment revealed no archaeological heritage resources.

The SA Palaeontological Sensitivity Map indicates that the study area has Moderate fossil sensitivity. No palaeontological assessment is attached to this case.
