ABC Prieska Solar (Pty) Ltd has proposed the establishment of a 75 MW Photovoltaic Solar Facility on the Remaining Extent of Erf 1 Prieska, Northern Cape Province. The plant will be approximately 300 ha in size and is currently zoned agricultural. The facility infrastructure will incorporate new internal roads; a water supply line, water booster pump station and water storage facility; ablution facilities, mess area and conservancy tanks; an overhead power line and substations/transformers connecting the facility to the Eskom grid; security fencing, an office, guard house and a warehouse.

The archaeological assessment comprised background research and a field survey. Background research revealed that the region has a significant number of archaeological and historic artefacts and sites, with Stone Age sites predominating. The field inspection identified scatters of stone tools that were most dense closest to the Eskom substation. These tools included some ESA materials, MSA retouched flakes, scrapers, blades, points and cores and were *ex situ* and heavily weathered. No burials were identified on the site, although a municipal cemetery exists beyond the development footprint. The authors note that the area forms part of the regional cultural landscape associated with the history of white settlement, colonial wars and the arrival of black African's in the area, with the area surrounding the development site containing urban settlements associated with the mines.

No palaeontological assessment was conducted.

### Decision:

SAHRA requires that:

 A palaeontological assessment be compiled for the study area to assess whether or not the development will impact upon palaeontological resources (see attached list of accredited Palaeontologists). If this is deemed unnecessary, a letter of recommendation for exemption from a professional Palaeontologist is needed.
