Savannah Environmental (Pty) Ltd is conducting a Basic Assessment process for a proposed 132kV to 66kV step-down substation on Portion 8 of Farm Damfontein 114 to connect five proposed Solar Energy Facilities to the Eskom grid. A Phase 1 AIA and a Desktop PIA were submitted to SAHRA for assessment.

The proposed Damfontein Solar Energy Facility is situated approximately 300m to the south west of the proposed substation area. The AIA indicated good archaeological visibility on the property. The AIA identified several surface scatters of mainly Middle Stone Age origin on the property. These sites are likely out of context and as such, have been graded as having low archaeological significance.

According to the Desktop Palaeontological Report, the area proposed for development falls within the Dicynodon Assemblage Zone of the Adelaide Subgroup which is characterised by herbivorous Synapsid fossils. These palaeontological resources are accorded high significance. As such, SAHRA requested that a foot survey of the site be completed.

Based on the submitted PIA, most of the project area is covered in Cenozoic age sheet wash. Adelaide Group exposure were concentrated in the central portion of the study area. No fossil material was identified in any portion of the study area during the foot survey. As the impact of the proposed development is likely to be restricted to the upper most few meters of land surface, it is unlikely that the proposed development will impact on any significant palaeontological resources. However, if any impact does occur, this impact will be significant.



If the newly discovered heritage resources prove to be of archaeological or palaeontological significance a Phase 2 rescue operation might be necessary.
