# Maintenance and Repair of Infrastructure Elements at St. Helena Bay Harbour, Erf number 78, St. Helena Bay, Saldanha Bay Local Municipality, West Coast District Municipality, Western Cape

Aurecon South Africa Pty Ltd was requested by the Coega Development Corporation (CDC) on the behalf of the Department of Public Works to undertake the coastal engineering infrastructure activities Work Package 3 of the Proclaimed Fishing Harbours Western Cape Development Programme, also known as the small harbours programme. This work package includes the coastal harbour of St Helena Bay.

The harbour at St Helena Bay was built in 1968 and has four jetties and four quays, with several smaller jetties built along the coast for fish factories. The harbour basin contains extensive areas of revetments and undeveloped water's edge. The proposed works will entail the repair and maintenance of existing harbour structures. No expansion of the existing footprint will occur as a result of these works.

The project involves the following aspects:

- repairs to concrete structures;
- repairs to wooden jetties;
- maintenance of main slipway and recreational boat launch;
- maintenance of the shore crane;
- dredging of the harbour basin;
- removal of four sunken vessels and one abandoned vessel.

The South African Heritage Resources Agency would like to thank you for submitting the Site Specific Maintenance Management Plan (MMP) for St Helena Bay Harbour, St Helena Bay, Saldanha Bay Local Municipality, Western Cape.

SAHRA first issued a comment on the project in April 2017 in response to the Notification of Intent to Develop. It was noted that none of the proposed works required further input from SAHRA as the harbour infrastructure and the sunken vessels were not older than 60 years. The proposed dredging also did not exceed beyond a

SAHRA did however recommend that any dredged material should not be disposed of near a known shipwreck site and that should any historic material be exposed during the works then we should be notified immediately. SAHRA is pleased to note that these recommendations have been taken into account and are included in the MMP.
