We acknowledge receipt of your invitation for comment on the Heritage Impact Assessment undertaken by Gavin Whitelaw, Frans E Roodt and Frans Roodt on the proposed development cited above. It is noted that the survey by these Cultural Heritage Practitioners did not yield any heritage resources within the development footprint. The developer can therefore proceed with the Stream Flow Reduction activity as planned.

The developer should adhere to the recommendations outlined in the report as well as the following standard conditions:

Conditions:

1. Amafa should be contacted if any heritage objects are identified during earthmoving activities and all development should cease until further notice.
2. No structures older than sixty years or parts thereof are allowed to be demolished altered or extended without a permit from Amafa.
3. No activities are allowed within 50m of a site, which contains rock art.
