The proposed Eucalyptus forestry projects by BJ Mbanjwa (100ha), occurring in the location Roodewal 209 farms in UMzimkhulu local Municipality within Sisonke District of Kwazulu Natal Province. This applicant is sub-quaternary T52H.

Invitation to comment on the Heritage Impact Assessment Report pertaining to the proposed Streamflow Reduction Activities in the area cited in this letter is acknowledged. The survey revealed presence of a lower grinding stone and a rectangular stone wall foundation. The probability of unknown graves and other chance finds near the homestead is high, thus monitoring during development and ground works is recommended. A Heritage Impact Assessment is required during site clearance phase and initial ground turning process to ensure artefacts and other cultural finds are not damaged or lost during the ground preparation phase.

Development may therefore proceed as planned within the parameters of the recommendations and mitigation procedures highlighted in the report by Gavin Whitelaw, Frans E Roodt, and Frans Roodt of Shasa Heritage Consulting. You are also required to adhere to the below-mentioned standard conditions:

Conditions:

1. Amafa should be contacted if any heritage objects are identified during earthmoving activities and all development should cease until further notice.
2. No structures older than sixty years or parts thereof are allowed to be demolished altered or extended without a permit from Amafa.
3. No activities are allowed within 50m of a site, which contains rock art.
