**The proposed Eucalyptus forestry projects by W.P Mahlawe (40ha), occurring in location in Vlakplaats 110ES Portion 10 (a portion of 2), farms in UMzimkhulu local Municipality within Sisonke District of Kwazulu Natal Province**

We acknowledge receipt of the invitation to comment on the Heritage Impact Assessment Report by Gavin Whitelaw and Frans E Roodt and Frans Roodt of Shasi Heritage Consultants submitted via the SAHRIS facility. The survey conducted under the Principal Heritage Specialist, Gavin Whitelaw did not yield much within the development footprint except a grave shown to Mr. Roodt by the developer, Mr. Mahlawe. The developer should not allow the forestry development to encroach into the burial ground. A 25 m buffer should be maintained between the grave boundary fence and any development including this forestry activity.

Since the grave is well known and will not to be impacted upon by the proposed development, development may proceed as planned within limits of the prescribed mitigation procedures.

You are also required to adhere to the below-mentioned standard conditions:

Conditions:

1. Amafa should be contacted if any heritage objects are identified during earthmoving activities and all development should cease until further notice.
2. No structures older than sixty years or parts thereof are allowed to be demolished altered or extended without a permit from Amafa.
3. No activities are allowed within 50m of a site, which contains rock art.
