The proposed forestry projects by S.R.Ntanzi (40ha) in respect of the same activity occurring in several locations in Roodewal 148ES Portion 12 farm in UMzimkhulu local Municipality within Sisonke District of Kwazulu Natal Province

We acknowledge receipt of your invitation for comment with regards to the proposed development. A grave and a cemetery with 18 graves was identified on this farm during the survey. The graves should be fenced off and a 25m buffer should be maintained between the identified heritage sites and the boundary fence.

In view of the findings outlined in the HIA Report by Gavin Whitelaw, Frans E Roodt and Frans Roodt of Shasa Heritage that we received for the above proposed development, we have no objection to the proposed development within limits of the prescribed mitigation measures and recommendations.

You are also required to adhere to the below-mentioned standard conditions:

Conditions:

1. Amafa should be contacted if any heritage objects are identified during earthmoving activities and all development should cease until further notice.
2. No structures older than sixty years or parts thereof are allowed to be demolished altered or extended without a permit from Amafa.
3. No activities are allowed within 50m of a site, which contains rock art.
