

Final Comment

In terms of Section 38(8) of the National Heritage Resources Act (Act 25 of 1999) and the KwaZulu-Natal Heritage Act (Act 4 of 2008)

The proposed forestry projects by Zala, C.W. (10ha) in respect of the same activity occurring in several locations in Bedford 180ES Portion A farm in Umzimkhulu and Ubuhlebezwe local Municipalities within Sisonke District of Kwazulu Natal Province

We acknowledge receipt of the Heritage Impact Assessment Reports by Gavin Whitelaw, Frans E. Roodt & Frans Roodt of Shasa Heritage Consultants. Although the area is associated with presence of heritage resources, the survey report established that no significant heritage resources such as archaeological or historical material or places of social or religious significance were found on the site of proposed development. In view of these findings, the development may proceed as planned.

Possibility of chance finds of cultural material can not be ruled out and therefore the developer is also required to adhere to the below-mentioned standard conditions:

Conditions:

- 1. Amafa should be contacted if any heritage objects are identified during earthmoving activities and all development should cease until further notice.
- 2. No structures older than sixty years or parts thereof are allowed to be demolished altered or extended without a permit from Amafa.
- 3. No activities are allowed within 50m of a site, which contains rock art.
