The permit application in respect of the above, received on the 11 September 2023 reviewed by the KwaZulu-Natal Amafa and Research Institute (The Institute) on the 06 September 2023 refers.

Please be advised as follows:

- The HIA has indicated that the property is on a hill which is near the ocean, often they have Early and/or Late Iron Age sites with shell middens and spatial features.
- It was also noted that there are existing remains of buildings and ruins or remains of middens however these could not be studied due to the very dense vegetation on this site.
- It is therefore required that the site be cleared and detailed built environment specialist studies for the buildings and an archaeologist study for the middens be conducted.

Written responses/requests for reconsideration of the application or consideration of new information must be loaded to the case on Sahris (email khanyi.zondi@amafainstitute.org.za) within 30 days of the date of this letter or any requirements/decisions contained herein will be considered final. Extensions of this time frame can be requested upon receipt of motivation.
