We acknowledge receipt of your invitation for comment with regards to the proposed development. We concur with the following recommendations proposed by the Heritage Practitioner regarding the proposed N2 Road Upgrade between Mthunzini Toll Plaza and Empangeni T-Junction:

- The development should proceed from a heritage point of view as no heritage resources were identified within 50m the proposed route upgrade.
- Construction activities should be limited to the proposed construction corridor of 20 m from the outer edge of the existing shoulder.
- If the size of the construction corridor is increased at a later stage, a heritage specialist should be involved in order to assess how the increase in the corridor width will affect heritage resources.

In view of the findings outlined in the HIA Report by Mamoluoane Seliane of Strategic Environmental Focus (Pty) Ltd that we received for the above proposed development, we have no objection to the proposed development within limits of the prescribed mitigation measures and recommendations.

You are also required to adhere to the below-mentioned standard conditions:

Conditions:

1. No structures older than sixty years or parts thereof are allowed to be demolished altered or extended without a permit from Amafa.
2. No activities are allowed within 50m of a site, which contains rock art.
