Final Comment

In terms of Section 38(8) of the National Heritage Resources Act (Act 25 of 1999) and the KwaZulu-Natal Heritage Act (Act 4 of 2008)

Attention: Van Eeden Projects Trust

Van Eeden Projects Trust intends to apply for a mining permit to mine 4.9 ha of a portion of Portion 1 of Lot 29 Umfolozi No 15607, Mtubatuba, Kwa-Zulu Natal Province.

Thank you for providing Amafa with the Heritage Impact Assessment Exemption Motivation authored by eThembeni and submitted to Amafa by Greenmined Environmental via the SAHRIS on-line Facility on 1 March 2016. The motivation letter indicates that there is no evidence of Cretaceous fossils or Stone Age and Iron Age archaeological material observed on the site. The developer should note that this does not rule out the possibility of chance finds.

Considering the findings based on eThembeni Heritage site visit Amafa has no objection to the proposed development within limits of the prescribed mitigation measures and recommendations.

You are also required to adhere to the below-mentioned standard conditions:

Conditions:

1. Amafa should be contacted if any heritage objects are identified during earthmoving activities and all development should cease until further notice.
2. No structures older than sixty years or parts thereof are allowed to be demolished altered or extended without a permit from Amafa.
3. No activities are allowed within 50m of a site, which contains rock art.
4. Sources of all natural materials (including topsoil, sand, natural gravels, crushed stone, asphalt, etc.) must be obtained in a sustainable manner and in compliance with the heritage legislation.

Failure to comply with the requirements of the National Heritage Resources Act and the KwaZulu Natal Heritage Resources Act could lead to legal action being instituted against the applicant.
