The applicant, eThekwini Municipality Water and Sanitation Unit, proposes the installation of a 500mm diameter steel water pipeline of approximately 10km to the Zwelibomvu 2 Reservoir. The pipeline will connect the Shongweni Reservoir to the Zwelibomvu 2 Reservoir. The intention is to replace the existing 300mm diameter glass fibre reinforced polyester (GRP) inlet pipeline to Zwelibomvu. The new pipeline will be installed within 2m of the existing line and will follow the same route as the existing pipeline.

Thank you for the opportunity to comment on the application as outlined above. The survey by Jean beater established that there are heritage resources in the area of proposed development. The heritage practitioner recommends that the development proceed as planned in line with the recommendations and mitigation measures provided to protect the identified heritage resources as outlined in section 7,8 and 9 of the Heritage Impact Assessment Report . We concur with the heritage practitioner and further require monitoring of the project by a heritage practitioner to ensure that the heritage resources are not compromised. The developer is required to ensure that the heritage resources are not disturbed, damaged, destroyed, altered, inundated, exhumed and relocated or otherwise disturbed without a permit from the KwaZulu Natal Amafa And Research Institute and other permitting authorities.

The KwaZulu Natal Amafa and Research Institute, therefore has no objection to the proposed development within limits of the stipulated conditions and mitigation measures.

You are also required to adhere to the below-mentioned standard conditions:
