Intent disposal of the SAS Somerset Vessel in terms of Section 9(3) of the National Heritage Resources Act 25 of 1999

In terms of section 9(3) of the National Heritage Resources Act, No. 25 of 1999, SAHRA issued a final comment, regarding Iziko's intention to alienate the SAS Somerset, a shipping vessel, located at the Waterfront, Cape Town, on the 02 May 2019. Subsequently, on 04 February 2020, Iziko forwarded correspondence on SAHRIS, Case ID: 13407, regarding the change in the method of disposal of the SAS Somerset. As per the initial notification, Iziko reported that they intended to scrap the vessel as because they were not in a position to conserve and preserve the vessel. Subsequent to this decision, on the advice of a law firm, Iziko had to reconsider and decided to sell the vessel.
