## Interim Comment

In terms of Section 38(8) of the National Heritage Resources Act (Act 25 of 1999) and the KwaZulu-Natal Heritage Act (Act 4 of 2008)

The Kwa-Zulu Natal Department of Transport (Applicant), proposes to upgrade the existing Local Road L1347 road to a type 7A gravel road. The proposed road will be approximately 4km in length and 8m wide (at certain portions of the route), with a 20m road reserve as per the Department of Transport standard dimensions for a type 7A gravel road. Furthermore, the Applicant proposes to upgrade any existing structures within the identified drainage lines. The Applicant proposes to install: 1 no. x 600mm pipe culvert structure, 1 no. x 900mm pipe culvert structure, 2 no. X 900mm pipe culvert structures and a slab structure respectively, which will assist flow into the adjacent drainage lines. The Applicant also proposes to install storm water drains along the proposed route to assist with surface run-off. The route traverses 4 no. drainage lines

Thank you for the opportunity to comment on the above proposed project. Having perused the information provided on the project, Amafa aKwaZulu Natali requires that a full Heritage Impact assessment be conducted on the total development footprint.
