The proposed development entails a residential development referred to as Anchorville Extension 12, situated on Portion 185 (a Portion of Portion 182) of the farm Roodepoort 302 I.Q. The farm portion is situated east and adjacent to the R558 (Lenasia Drive), in the Lenasia area and falls within the jurisdiction of the City of Johannesburg Metropolitan Municipality (Region G, Ward 8).

The assessment identified no significant archaeological heritage resources.

## **Interim Comment**


The SA Palaeontolgical Sensitivity Map indicates that the study area is of Very High fossil sensitivity and therefore SAHRA requires a palaeontological field assessment and protocol for finds. Once this assessment has been submitted to SAHRA, the SAHRA Archaeology, Palaeontology and Meteorites Unit will be able to provide final comments.

Considering that no significant archaeological heritage resources occur within the study area, the SAHRA Archaeology, Palaeontology and Meteorites Unit has no objections to this proposed development in terms of archaeological heritage resources, on the following conditions:

- If any evidence of archaeological sites or remains (e.g., remnants of stone-made structures, indigenous ceramics, bones, stone artefacts, ostrich eggshell fragments and charcoal/ash concentrations) or other categories of archaeological heritage resources are found during the proposed activities, SAHRA must be alerted immediately, and a professional archaeologist must be contacted as soon as possible to inspect the findings. If the newly discovered heritage resources prove to be of archaeological significance a Phase 2 rescue operation might be necessary.
