The applicant's intention is to develop 252 Residential stands, 1 Institutional stand- Erf for a place of public worship and instruction, 1 Institutional stand- Erf for a clinic, 3 Public Open Space erven and streets.

The proposed development entails a residential development with associated infrastructure.

The assessment identified no heritage resources.

The SA National Fossil Sensitivity Map indicates that the fossil sensitivity is insignificant and therefore no palaeontological assessment is required.

Please note that the SAHRA APM Unit does not usually accept assessment reports that are older than five years, however, considering the highly disturbed nature of the study area, SAHRA is willing to accept the report in this instance.

Final Comment

As there is apparently no evidence of any significant archaeological or palaeontological material in this area, the SAHRA Archaeology, Palaeontology and Meteorites Unit has no objection to the development. If any new evidence of archaeological sites or artefacts, palaeontological fossils, graves or other heritage resources is found during development, SAHRA and an archaeologist and/or palaeontologist, depending on the nature of the finds, must be alerted immediately.
