Pelser, A. October 2014. Report On The Assessment Of Structures On Erf 283, Menlo Park, Gauteng

The assessment was conducted on the homestead and associated structures on Erf 283 (between Mackenzie & 11th Streets) in Menlo Park.

The site is characterized by residential structures (homestead and related buildings/features) that have been abandoned recently in lieu of the planned re-development of the site into a Sectional Title Residential development. The structures recorded appear to date to the 1960s or 1970s.

Final Comment

Considering that no archaeological or palaeontological heritage resources were recorded, the SAHRA Archaeology, Palaeontology and Meteorites Unit has no comment relating to the development, and no objection to the development in terms of archaeological or palaeontological heritage resources.

Comments and decisions relating to the residential structures present on the study area must be obtained from the Gauteng Provincial Heritage Resources Authority prior to any development taking place.
