The proposed development entails a residential township and related infrastructure, the property is situated between Olifant Street, Serenade Road, Amber Road and Kraft Road (M57 / Jet Park Road) and abuts Elandsfontein residential township on the southwest.

The assessment recorded no sites of cultural heritage significance.

The SA Palaeontological Sensitivity Map indicates that the study area has Low fossil sensitivity.

### **Final Comment**

In terms of archaeological and palaeontological heritage, the SAHRA Archaeology, Palaeontology and Meteorites Unit has no objections to this proposed development, provided that the recommendations in the specialist reports and this comment are adhered to, and on the following conditions:

- no palaeontological studies are required however a protocol for finds is required
- If any evidence of archaeological sites or remains (e.g., remnants of stone-made structures, indigenous ceramics, bones, stone artefacts, ostrich eggshell fragments and charcoal/ash concentrations) or palaeontological remains are found during the proposed activities, SAHRA must be alerted immediately, and a professional archaeologist or palaeontologist, based on the nature of the finds, must be contacted as soon as possible to inspect the findings. If the newly discovered heritage resources prove to be of significance a Phase 2 rescue operation might be necessary.
