The development is located on the remaining extent of Erf 984 in Constantia Kloof Extension 25, Roodepoort.

The proposed development entails a project by Abland (Pty) Ltd aim to confine the 1:100 year flood line of the man-made dam at Constantia Boulevard, in order to use the neighbouring property as office space. Construction will include increasing the height of the existing dam wall and developing the area adjacent to the dam wall into a parking area for the Nedbank Lakeview Data Centre. The project also includes the expansion of the Nedbank Lakeview Data Centre (phase 2) to within 32 metres of the Constantia Dam, as well as an attenuation facility to be constructed on the periphery of the dam for the attenuation of storm water.

The project area is located between Constantia Kloof and Flora Cliff in Roodepoort, and has seen extensive residential development, while office parks, shopping complexes and a hotel surround the lake area.

Literature review and archival research, along with a field survey revealed that the area has been extensively disturbed and the author states that no sites, features or objects of cultural heritage significance were identified.

### **Case Decision**

As there is apparently no evidence of any significant archaeological material in this area, the SAHRA Archaeology, Palaeontology and Meteorites Unit has no objection to the development (in terms of the archjaeological component of the heritage resources) on condition that, if any new evidence of archaeological sites or artefacts, palaeontological fossils, graves or other heritage resources are found during development, construction or mining, SAHRA or an archaeologist must be alerted immediately.
