## **Final Comment**

The proposed development entails the upgrade of a pipe bridge in Libertas Avenue and the cleaning of the Wilgespruit between Libertas Ave and Cura Ave in Equestria, Pretoria.

The report indicates that the project impact area is located in a highly urbanised zone on a busy road between a housing estate and other residential properties. Urbanisation of the project area was determined to have started from 1968 and became fully urbanised by 2004 and there is significant evidence of construction and dumping within and surrounding the project area.

In addition, reviews of existing impact assessment reports indicated that the project area had been surveyed previously, and no significant heritage resources have been identified during these surveys.

The authors contend that the likelihood of any significant in situ archaeological, historical and palaeontological resources occurring is minimal and that no further heritage studies or mitigation measures are required and request exemption from further heritage studies.

## **Case Decision**

As there is apparently no evidence of any significant archaeological or palaeontological material in this area, the SAHRA Archaeology, Palaeontology and Meteorites Unit has no objection to the development and requires no further heritage studies, on condition that, if any new evidence of archaeological sites or artefacts, palaeontological material, graves or other heritage resources are found during development, construction or mining, SAHRA or an archaeologist/palaeontologist must be alerted immediately.
