The proposed project entails a mixed use township establishment located on Portion 297, Portion 299 and Portion 303 of the Farm Haakdoornboom 276 JR, Shoshanguve, Gauteng Province.

The assessment yielded no archaeological heritage resources within the study area.

No palaeontological assessment has been submitted. The SA Palaeontological Sensitivity Map indicates that the study area has both Low and High fossil sensitivity.

Interim Comment

Considering that no significant archaeological heritage resources occur within the study area, the SAHRA Archaeology, Palaeontology and Meteorites Unit has no objections to this proposed development on the following conditions:

If any evidence of archaeological sites or remains (e.g., remnants of stone-made structures, indigenous ceramics, bones, stone artefacts, ostrich eggshell fragments and charcoal/ash concentrations) are found during the proposed activities, SAHRA must be alerted immediately, and a professional archaeologist must be contacted as soon as possible to inspect the findings. If the newly discovered heritage resources prove to be of archaeological significance a Phase 2 rescue operation might be necessary.

The SA Palaeontological Sensitivity Map indicates that the study area has both Low and High fossil sensitivity, therefore a desktop study is required and based on the outcome of the desktop study, a field assessment may be required. Once this assessment has been submitted, SAHRA will be able to make further comments.
