Final Comment

The proposed development entails a residential township and associated infrastructure.

The archaeological assessment revealed that the study area has been disturbed by cultivation in the 1970s and more recently by surrounding township and road developments. These activities would have impacted on heritage features if any ever occurred in these areas and the project area is considered to be of low heritage potential. This was confirmed during the field survey and no heritage finds of significance were recorded.

The palaeontological assessment concluded that it is extremely unlikely that any fossils would be preserved in the sands and soils of the Quaternary. There is a very small chance that fossils may occur in the Black Reef formation according to the SAHRA Palaeotechnical Report, but the geology and more recent research do not support this claim. The author recommends that a Fossil Chance Find Protocol should be added to the Environmental Management Programme report in case there are fossils well below the ground surface.

Final Comment

In terms of archaeological and palaeontological heritage, the SAHRA Archaeology, Palaeontology and Meteorites Unit has no objections to this proposed development, provided that the recommendations in the above specialist reports and this comment are adhered to, and in addition, on the following conditions:

- A palaeontological Chance Find Protocol must be implemented by the Environmental Control Officer or site manager in charge of these developments.
- If any evidence of archaeological sites or remains (e.g., remnants of stone-made structures, indigenous

ceramics, bones, stone artefacts, ostrich eggshell fragments and charcoal/ash concentrations) or palaeontological remains are found during the proposed activities, SAHRA must be alerted immediately, and a professional archaeologist or palaeontologist, based on the nature of the finds, must be contacted as soon as possible to inspect the findings. If the newly discovered heritage resources prove to be of significance a Phase 2 rescue operation might be necessary.

If any unmarked human burials are uncovered and the archaeologist called in to inspect the finds and/or the police find them to be heritage graves, mitigation may be necessary and the SAHRA Burial Grounds and Graves (BGG) Unit must be contacted for processes to follow.
