The proposed development entails a road intersection, proposed to be constructed at the current T-junction of Rose Road and the R511. The study area is situated immediately north-east of Steyn City and West of Riversands Commercial Park in Fourways approximately 6.5 km north of Monte Casino along the R511.

No surface indicators of archaeological material was identified in the study area.

#### **Final Comment**

.Considering that no significant archaeological heritage resources occur within the study area ,and that the SA Palaeontological Sensitivity Map indicates that the study area has insignificant palaeontological sensitivity, the SAHRA Archaeology, Palaeontology and Meteorites Unit has no objections to this proposed development on the following conditions:

- If any evidence of archaeological sites or remains (e.g., remnants of stone-made structures, indigenous ceramics, bones, stone artefacts, ostrich eggshell fragments and charcoal/ash concentrations), fossils or other categories of heritage resources are found during the proposed activities, SAHRA must be alerted immediately, and a professional archaeologist or palaeontologist, depending on the nature of the finds, must be contacted as soon as possible to inspect the findings.
