The proposed development entails a new residential township on Portion 228 of the Farm Houtkop 594 IQ, Emfuleni Local Municipality, Gauteng Province and will comprise a total of 789 erven.

An archival and historical desktop study was undertaken and did not reveal any historic or heritage sites from within the study area. The desktop study work was followed by a fieldwork component which comprised a walkthrough of the study area whereby no heritage sites were identified within the study area.

### Case Decision

As there is apparently no evidence of any significant archaeological material in this area, the SAHRA Archaeology, Palaeontology and Meteorites Unit has no objection to the development (in terms of the archaeological component of the heritage resources) on condition that, if any new evidence of archaeological sites or artefacts, graves or other heritage resources are found during development, construction or mining, SAHRA or an archaeologist must be alerted immediately.

Considering that part of the study area is of high estimated palaeontological sensitivity. The SAHRA APM Unit requires that a Desktop Palaeontological Assessment be compiled and submitted to SAHRA for comment.
