The proposed development entails a township development with related infrastructure.

The assessment identified the following heritage resources:

Two cemeteries, one of approximately 150 graves, and another of approximately 200 graves. In addition to the two cemeteries, a possible single grave was found near the ruin of a farmworker's home.

The SA Palaeontological Sensitivity Map indicates that the study area has Moderate fossil sensitivity. No palaeontological assessment has been attached to this case.

Interim Comment

The possible single grave must be investigated by a grave relocation specialist and a report submitted to SAHRA. If any disturbance of the possible grave is required, the appropriate permit to do so must first be obtained from the SAHRA Burial Grounds and Graves Unit prior to any disturbance.

The two cemeteries must be demarcated by a heritage specialist and fenced, with a buffer zone of at least 30 metres between the fence and any development. A site management plan detailing strict site management conservation measures for the cemeteries must be compiled prior to the commencement of construction.

In terms of palaeontological heritage, the SA Palaeontological Sensitivity Map indicates that the study area has Moderate fossil sensitivity, therefore a desktop palaeontological study is required. Once this study has been submitted to SAHRA, SAHRA APM will be able to provide further comments.
