AMENDMENT OF APPROVED TOWNSHIP ON A PART OF PORTION 69, KOEDOESPOORT 325-JR Van Schalkwyk, J. October 2016. Cultural heritage impact assessment for The Proposed Township Establishment On Part Of Portion 69 Of The Farm Koedoespoort 325JR, City Of Tshwane, Gauteng Province

The proposed development entails a new residential township and associated infrastructure.

The author states that no sites, features or objects of archaeological cultural heritage significance were identified in the study area.

The SA Palaeontological Sensitivity Map indicates that the study area has High fossil sensitivity. No palaeontological assessment has been attached to this case.

Interim Comment

In terms of palaeontological heritage, the SA Palaeontological Sensitivity Map indicates that a part of the study area has High fossil sensitivity, therefore a palaeontological desktop study is required and must be submitted to SAHRA for comment.

In terms of archaeology, the SAHRA Archaeology, Palaeontology and Meteorites Unit has no objections to this proposed development, provided that the recommendations in the specialist reports and this comment are adhered to, and on the following conditions:

- If any evidence of archaeological sites or remains (e.g., remnants of stone-made structures, indigenous ceramics, bones, stone artefacts, ostrich eggshell fragments and charcoal/ash concentrations) are found during the proposed activities, SAHRA must be alerted immediately, and a professional archaeologist must be contacted as soon as possible to inspect the findings. If the newly discovered heritage resources prove to be
