Basic Assessment process for an application for rezoning for the purposes of a proposed residential development, service station and commercial activities on Zwavelpoort 373-JR Portions 116 and 130.

The proposed development entails a residential development, service station and commercial activities on Zwavelpoort 373JR Portions 116 and 130.

The author states that previous assessments of parts of the study area have identified three archaeological heritage sites, and that numerous sites have also been recorded during various Impact Assessments within the 5km inclusion zone which has been set out in the Heritage Screener. The author recommends that an Archaeological Impact Assessment of the study area be undertaken.

In terms of palaeontological heritage, the area is underlain by three fossil formations of the Pretoria Group, Transvaal Supergroup. These are: the Hekpoort Formation of moderate sensitivity, composed of volcanic rocks (basalts and pyroclastics) with minor lacustrine shales? the Strubenkop Formation composed of lacustrine mudrocks with minor sandstone of low fossil sensitivity? the Daspoort Formation, of high sensitivity, which covers only a small portion of the area and have been affirmed in a palaeontological assessment in 2014 as having no identified fossils. The author recommends that no Palaeontological Impact Assessment be undertaken but that a Fossil Chance Find Procedure be included in the EMP.

Interim Comment

In terms of palaeontological heritage, the Archaeology, Palaeontology and Meteorites Unit supports the recommendations of the author that no Palaeontological Impact Assessment be undertaken but that a Fossil Chance Find Procedure be included in the EMP.

In terms of archaeology, the SAHRA Archaeology, Palaeontology and Meteorites Unit Unit supports the recommendations of the author that an Archaeological Impact Assessment of the study area be undertaken. This assessment must be submitted to SAHRA for comment prior to any development activities taking place.
