Eskom proposes the development of a 667m 22kV power line running along road servitude in the Sibase township near Thohoyandou, Thulamela local Municiplaity. The report submitted assessed the potential of the presence of possible archaeological resources. The area was found to be disturbed and no archaeological or any other heritage resources were identified during the Phase 1 Assessment.


