AMENDMENT OF AN ENVIRONMENTAL AUTHORISATION FOR THE PROPOSED ESTABLISHMENT OF A TRANSPORT TRUCK YARD ON PORTION 29 OF THE FARM GOEDEHOOP 308 IR, GOVAN MBEKI LOCAL MUNICIPALITY, MPUMALANGA PROVINCE.

Your application on the above matter refers.

1. The Department has, in terms of the powers vested in it by regulation 45 of the Environmental Impact Assessment Regulations, 2010, decided to amend the Environmental Authorisation.
2. The amendment entails the inclusion and exclusion of the authorized listed activities which were erroneously left out or included in the environmental authorisation date 05 November 2012.

3. **The factors considered in granting the amendment are:**

- a) The listed activities were incorrectly captured in the Environmental Authorisation.
 - b) The amendment will only result in the authorisation of the listed activities that were originally applied for.
 - c) No additional impacts will occur as a result of the amendment.
 - d) The amended layout plan does not result in new listed activities being triggered.
 - e) The changes are not anticipated to negatively impact on the environment.
 - f) The activity will still be located on the same footprint.
4. The Department does not deem the amendment to be substantive and to result in significant environmental impacts that would conflict with the general objectives of integrated environmental management as laid down in Chapter 5 of the National Environmental Management Act, 1998 (Act No. 107 of 1998).
5. All the conditions relevant to the listed activities contained in the environmental authorisation are still enforceable and are not amended in anyway.
6. You are instructed in terms of regulation 10(2) of the Regulations to notify all registered interested and affected parties, **in writing and within 12 days of the date of this letter**, of the Department's decision to amend the environmental authorisation as well as the provisions regarding the making of appeals that are provided for in the regulations.
7. Your attention is drawn to Chapter 7 of the Regulations which regulates appeal procedures. Appeals may be lodged by means of one of the following methods:
