- 1. The Jaspairs Trading and Projects (Pty) Limited, Prospecting of DIAMOND (DIA), DIAMOND (ALLUVIAL) (DA), DIAMOND (GENERAL) (D), DIAMOND (IN KIMBERLITE) (DK), GOLD ORE (Au), SILVER ORE (Ag), GEMSTONES EXCEPT DIAMONDS (GS), PLATINUM GROUP METALS (PGM), ALUMINIUM ORE (Al), CHROME ORE (Cr), COBALT (Co), COPPER ORE (Cu), LEAD (Pb), IRON ORE (Fe), MOLYBDENUM ORE (Mo), NICKEL ORE (Ni), RARE EARTHS (RE), SILICON ORE (Si), TIN ORE (SN), TUNGSTEN ORE (W), VANADIUM ORE (V), ZINC ORE (ZN), ZIRCONIUM ORE (ZR) ON PORTION 1 AND REMAINDER OF THE FARM KONGONI 311 SITUATED IN THE MAGISTERIAL DISTRICT OF KURUMAN NORTHERN CAPE PROVINCE.
- 2. The Jaspairs Trading and Projects (Pty) Limited, Prospecting of MANGANESE ORE (Mn), IRON ORE (Fe), ZINC ORE (Zn), COPPER ORE (Cu) AND LEAD (Pb) ON FARM CONSTANTIA 309 AND FARM SIMONDIUM 308 SITUATED IN THE MAGISTERIAL DISTRICT OF KURUMAN NORTHERN CAPE PROVINCE.

During the time when we were busy conducting background studies of the aforementioned proposed projects, it transpires that these projects are located in the area where Archaeological Impact Assessment (AIA) have already been conducted, in 2010 and 2012 respectively and for comparable projects. These AIA, which are on the same farm, covered the same extent as your proposal, and were conducted by professional archaeologist. Hence, as an independent archaeologist, I recommend that you request an exemption from SAHRA, where in an AIA is not redone, since the area has been surveyed, and no new materials are expected. Conversely, the recommendation as stipulated in these reports must be adopted and abided at all times, during the process of prospecting. Attached please find the reports as uploaded from sahris.
