

**33. DIE DUBBELVERDIEPING VICTORIAANSE WOONHUIS, TE TUINE, KAAPSTAD**

*Beskrywing:*

Die eiendom met die dubbelverdieping Victoriaanse woonhuis daarop, geleë op Erf 94523, Kaapstad, te Tuine, in die stad Kaapstad, Kaapse Afdeling, en groot tweehonderd en vyftien (215 vierkante meter).

**34. DIE KIMBERLEY GIRLS' HIGH SCHOOL-GEBOUEKOMPLEKS, KIMBERLEY**

*Beskrywing:*

**35. DIE TRINITY CHURCH-KOMPLEKS, GRAHAMSTAD**

*Beskrywing:*

**37. LONG COTTAGE, NEWLANDS, KAAPSTAD**

**35. THE TRINITY CHURCH COMPLEX, GRAHAMSTOWN**

*Description:*

**37. LONG COTTAGE, NEWLANDS, CAPE TOWN**
